Report of the Chairman

Meetings Portland meeting held April 21-22, 1947 under chairmanship of Wayne D. Criddle with R. A. Work acting as program chairman. Records of the business meeting were mimeographed and distributed early this year. Reprints of papers read at the Sacramento meeting held February 27, 1946 have been ordered for distribution to W.S.C. members and contributing agencies. Papers from the last W.S.C. meeting are still awaiting publication by A.G.U. except those published in the 1948 Snow Surveyors' Forum.

Supporting

Organizations In December 1947 all supporting organizations who were known to be able to contribute without purchasing transactions or reprints were canvassed. Some 18 companies or organizations contributed from \$5.00 to \$25.00 each. As soon as reprints of the papers read at the Western Snow Conference in 1946 are available, some additional 30 organizations will be canvassed.

Transactions

Those papers of the 1946 Western Snow Conference considered by the Editorial Committee of the A.G.U. to be of such a nature as to warrant their publication in the Transactions appeared in October and December 1947. On December 22 your General Chairman wrote to the A.G.U. requesting the feasibility and cost of getting reprints of these papers for distribution to W.S.C. members and member organizations. On February 24 a letter was received from the A.G.U. stating that reprints could be obtained and they would supply us cost data if we would indicate which papers were desired. This was done and the price quoted for 1000 copies of a 60-page reprint was \$280. Therefore, 1000 copies were ordered.

Snow Surveyors' Forum Again the Snow Surveyors Forum was prepared and published. Fred Paget assisted by Ralph Parshall did another fine job. Reactions

from the field men indicate this booklet as being extremely valuable in tying the field man and the more "technical men" together.

Report of the Treasurer as of April 12, 1948

With your permission gentlemen, I will dispense with reading the detailed account of receipts and disbursements. The complete record is here and will appear in the proceedings of the meeting. The summary shows that on April 15, 1947 the Conference had a balance of \$1,096.91 on hand. From that time until April 12, 1948 the income from all sources amounted to \$540.68 and the expenditures were \$625.23, leaving a bank balance as of April 12, 1948 of \$1,012.56. From April 12 to date (April 16, 1948) there has been no income nor bills paid. There will be some expense in connection with this conference that may not be covered by the registration fees.

Finances The treasurer's report shows a cash balance as of April 12 of \$1,012.56 with no liabilities and with but one account receivable for \$25.00. Therefore, our conference is completely solvent and should be able to carry forward to greater usefulness to the members and the public in general.

There is one account outstanding, 1000 copies of reprints of W.S.C. papers were ordered from the A.G.U. for \$280. Four orders for reprints totaling \$81.00 have already been received. There is every reason to believe that additional orders for \$400 will be received as soon as the reprints are ready for distribution.

The income to the Conference from membership dues and from supporting agencies since April 22, 1947 to April 12, 1948 has totaled \$540.68. Our expenditures have amounted to \$625.03 of which \$400 was for printing 1200 copies of our Snow Surveyors' Forum, \$84.60 for postage and stamped envelopes and the balance of \$140.43 for miscellaneous expense.
